WHAT IS UNITED REHABILITATION SERVICES?

United Rehabilitation Services (URS) is a nonprofit agency with a 63-year history of serving children and adults with disabilities in the Miami Valley. URS was originally founded as the Dayton Chapter of United Cerebral Palsy and today provides programs and services *each day* to more than 300 local children and adults with disabilities or other special needs. The following programs promote independence, community inclusion and support for local families:

For Children with Disabilities: *5-Star Rated Child Care and Early Childhood Education Programs with on-site Nursing Services and Therapies (6 weeks to 6 years), School-Age Program (7 years to 17), Summer Enrichment Program, and Parent Support Group*

For Adults with Disabilities: *Adult Activity Center, Employment Services, 1st and 2nd Shift Vocational Training, Senior Program, Caregiver Support Group and Recovery Counseling and Case Management Services*

Clinical Services: *On-site Physical Therapy, Occupational Therapy, Speech Therapy, Aquatic Therapy, Universal Exercise Unit "spider cage"*



WHAT IS THE URS RUBBER DUCK REGATTA?
